



Privacy Statement

We respect the privacy of visitors to the website and ensure that the personal data you give us is treated confidentially. Personal data is processed in accordance with the requirements of the General Data Protection Regulation (AVG).

Purposes of data processing

Your personal data will be processed by us for entering into and executing agreements concerning the rental of a recreation accommodation.

If you book an accommodation through the website, fill in a contact or registration form or send us an e-mail, the data you send us will be kept for as long as the type of form or content of your e-mail is necessary for the booking to be fully answered and completed.

Click behaviour and visitor data

General visitor data is kept on the website. Your computer IP address, any user name, the time of retrieval and data that a visitor browser sends, may be registered and used for statistical analyses of visitor and click behaviour on the website for this purpose. This also enables us to optimise the functionality of the website.

We try to keep visitor data as anonymous as possible. This data is not provided to third parties.

Google Analytics

We use Google Analytics to keep track of how users use the Website. The information obtained, including the address of your computer (IP address), is transferred to and stored by Google on servers in the United States.

Google uses this information to keep track of how our website is used, to provide us with reports on the Website and to provide its advertisers with information about the effectiveness of their campaigns. Google may provide this information to third parties if Google is legally obliged to do so, or insofar as these third parties process the information on behalf of Google. We have no influence on this.
